
WELLness Check Program – Welcome Letter Updated Target Participation Area

March 5th, 2024

Dear Landowner:

You are receiving this letter today to inform you of the update to the Target Participation Area and to invite you to participate in the WELLness Check Program if you have not done so already.

The **WELLness Check Program** was developed by Strada Aggregates (Strada) and North Dufferin Community and Agricultural Task Force (NDACT) to ensure the protection of water, wells, and natural features surrounding Strada’s proposed quarry location on the 4th Line, Melancthon. Information gathered from the **Program** will assist with understanding existing environmental conditions, monitoring those conditions, and ensuring the proposed quarry, if approved for a licence, will have no adverse effects on surrounding water, wells and the natural environment.

As part of this program, an area was identified surrounding the proposed quarry where properties within this Target Participation Area (TPA) were invited to participate in this Program. Letters introducing landowners to the Program were mailed in October 2023 and a subsequent Open House was held on November 9th, 2023 at the Horning’s Mills Community Centre to provide those landowners with an opportunity to learn about the WELLness Check Program.

Feedback was received during the Open House with landowners expressing concerns that only select properties within Horning’s Mills were included in the TPA. Listening to those concerns, Strada and NDACT have worked together to expand the TPA to also include every property within the Horning’s Mills community.

Generally, the geographic boundaries of the TPA now are:

- West: 5th Line
- North: 15 Sideroad
- East: Mulmur-Melancthon Townline
- South: County Rd 17

With this letter, we have also included some Frequently Asked Questions aimed at providing you with answers to common questions about the Program.


